

Please be prepared to include the following documents in your application:

Employment, Education and Guardianship:

- **Attendance Records** (if applicable)
- **High School Transcript (or most recent High School record)**
 - You will be *required* to upload this to the application.
- **Transcript or completion certificate from any other formal training** (if applicable)
- **Resume** (if applicable)
- **Vocational Fit Assessment** (if applicable)
- **Proof of guardianship (court documentations)**
 - You will be *required* to upload this to the application only if the individual's mother/father is not his/her legal guardian.

Evaluations:

- **Work-Based Learning Evaluation** (if applicable)
- **Physical Therapy Evaluation** (if applicable)
- **Occupational Therapy Evaluation** (if applicable)
- **Speech Language Pathology Evaluation** (if applicable)
- **Neurology Evaluation** (if applicable)
- **Psychology Evaluation** (if applicable)
- **Psychiatry Evaluation** (if applicable)
- **Other Evaluation** (if applicable)

Medical:

- **Dental Note**
 - Please have the applicant's dentist provide you a letter on official letterhead regarding his/her current dental health. You will be *required* to upload this to the application.
- **Immunization Records**
 - This form is required only for Project SEARCH applicants.
- **Fingerprinting Documents**
 - This form is required only for Project SEARCH applicants.
- **Medical Form**
 - This form is *required* and needs to be completed by the individual's physician. If the physician would prefer to use his/her own medical form it must include all information contained in the form provided by Kennedy Krieger Institute. Award Letter/s & Eligibility Documentation

- **Eligibility Award Letter/s: SSI, SSDI, Medicare, or Medicaid**
 - If the applicant is eligible, you will be *required* to upload proof of eligibility.
- **Developmental Disability Eligibility Documentation**
 - If the applicant is eligible, you will be *required* to upload proof of eligibility.
- **Department of Rehabilitation Services (DORS) Eligibility Documentation**
 - If the applicant is eligible, you will be *required* to upload proof of eligibility.

Plans (IP, IEP, Behavior & Emergency):

- **Behavior Plan**
 - If the applicant has a behavior plan, you will be *required* to upload this to the application.
- **Emergency Plan**
 - If the applicant has an emergency plan, you will be *required* to upload this to the application.
- **Current or Exiting Individual Education Plan (IEP) (including transition goals)**
 - If the applicant has a current or exiting Individual Education Plan, you will be *required* to upload this to the application.
- **Individual Plan/Person-Centered Plan (if applicable)**
 - If the applicant has a current Individual Plan/Person-Centered Plan, you will be *required* to upload this to the application.
