

DESCRIPTION

This activity is designed to create a learning community for pediatric primary care providers and allied health professionals. It will address the diagnosis, management, and treatment of developmental, emotional, and behavioral health conditions in children ages 0-8. The program's infrastructure is built on the "hub and spokes" design known as the Extension for Community Healthcare Outcomes (ECHO) model. Each ECHO session includes case-based learning and didactic instruction in an "all teach, all learn" environment.

WHO SHOULD ATTEND

This activity is intended for Physicians, nurse practitioners, physician assistants, school nurses, school educators, physical therapists, occupational therapists, psychologists, and social workers working with military families.

OBJECTIVES

After attending this activity, the learner will demonstrate the ability to:

- Recognize the prevalence and comorbidity of mental, emotional, developmental, and behavioral (MEDB) disorders in children.
- Identify children with or at risk for MEDB and complex medical conditions.
- Utilize evidence-based practices in the management of MEDB and complex medical conditions in young children.
- Identify resources to address MEDB and complex medical conditions in young children of military service members.
