## Psychiatric Social Work Post-Master's Fellowship

Psychiatric social work post-master's fellows will receive focused training in the interdisciplinary, evidence-based treatment of children, adolescents and young adults with mental health conditions. Collectively, our outpatients represent a wide range of diagnoses, neurodivergence and psychosocial situations, ensuring broad patient exposure for each fellow.

This is a two-year program, including didactics in core skills and evidence-based models of therapy, supervision/mentorship and direct patient care. Fellows will gain experience practicing core competencies and skills in evaluation and treatment planning, and in providing evidence-based therapy suitable to each patient's needs. Fellows will have the chance to work together as part of an interdisciplinary team of clinical social workers, psychologists, psychiatrists and nurses to meet each patient's unique needs.

### First year:

- Introduction and refinement of the core skills of evaluation, treatment planning and psychotherapy
- Basics of evidence-based cognitive behavioral therapy (CBT) taught through didactics and supervision of casework
- Weekly training course through the Maternal and Child Health Leadership Education in Neurodevelopmental and Other Related Disabilities (LEND) program
- Introduction to family and group therapies and opportunities to observe other evidence-based/evidence-informed models of therapy with a wide variety of patients
- Didactics and independent learning on ethics and the systemic impact of social factors
- Discussion of current topics in mental healthcare

Participation in the second year is contingent upon the successful completion of the first-year learning contract.



### Second year:

- In-depth learning of CBT, e.g., exposure and response prevention (ERP)
- Learning of other evidence-based/evidence-informed therapy models such as dialectical behavior therapy (DBT), acceptance and commitment therapy (ACT), motivational interviewing (MI), and models of family therapy and group curriculums
- Expansion of clinical practice with diverse patient populations
- Independent learning project, single-disciplinary or multidisciplinary quality improvement project, poster, or project resulting in a paper

At the conclusion of the two-year fellowship, participants will receive a certificate of completion and will have earned most of the supervision and practice hours required to apply to take the Maryland LCSW-C examination.



#### Additional information:

- Some fellowship activities are offered virtually, while others take place in person. Participants must be able to attend on-site training and practice activities at our Baltimore site.
- The training year runs from August through July.
- Fellows will be employed full time by Kennedy Krieger, will be compensated with a full-time salary and will receive full-time benefits.
- Fellows will be required to uphold a social work license (LMSW) from the Maryland Board of Social Work Examiners.
- Employees are permitted to use accrued paid vacation time after employment for a minimum of six months and successful completion of the employee's initial evaluation period.
- Fellows will have the opportunity to apply to continue employment at Kennedy Krieger Institute upon conclusion of the program.

#### Timeline:

- Application packets due: March 20, 2026
- Interviews: April-May 2026
- Decisions and notification: Mid-May 2026
- New employee orientation (on-site at Kennedy Krieger): August 10, 2026

#### Who may apply:

- Candidates who have graduated from an accredited school of social work, who hold a Maryland LMSW, and who have had no more than three years of professional social work experience may apply.
- Candidates may apply while completing the last semester of the advanced year of their Master of Social Work (MSW) program from an accredited school of social work.
  - For a candidate to be considered for an interview, their application packet must be accompanied by a passing score on the LMSW examination or proof of a scheduled examination date.
  - Candidates submitting an examination date must follow up by sending proof of a passing score on the exam. Final acceptance will be pending graduation and obtaining an LMSW license in the state of Maryland.

#### When to apply:

Application packets are **due by March 20, 2026**. Late or incomplete application packages will not be accepted.
